TERMS OF CONTRACT/ HEALTH GUARANTEE:

Kitten(s) has received all shots and parasite medication prior to pick-up, according to age. The purchaser has 48 hours to return said cat/ kitten, at purchaser's expense, if not verified to be healthy. Cat/ kitten must be isolated from all other animals during first 48 hours. All sales are final after 48 hours of purchaser receiving cat/ kitten. All cats/ kittens shipped arrive with a certificate of health, health certificates. Shipping expenses are the purchaser's financial responsibility. Deposits are Non-Refundable, but are completely transferable to any other upcoming litter, to another party if needed, and Deposits Never Expire. You may wait as long as you wish to find just the perfect kitten. No Expiration Date on Deposits as long as seller is breeding said breed. However, after a kitten is selected the deposit is non-refundable and the sale is considered final. Seller's instructions for recommended care of the cat/ kitten must be followed, including a complete examination by a licensed Veterinarian, during the first 48 hours of receiving said cat/ kitten. Administering of FIP or FeLv vaccine will void all warranty. It is the opinion of the seller that these vaccines are not only controversial, but possibly harmful to the animal. Veterinary expenses, and other cat-related purchases/ expenses incurred after the cat/ kitten leaves the cattery are the sole responsibility of the purchaser. Should said cat/kitten develop a proven genetic life-threatening illness or defect leading to death, a licensed veterinarian's written report and autopsy report, proving the cause of such illness or death originated at the Cattery will be required before any adjustment will be considered. Seller's liability shall be limited to the original purchase price and to the original purchaser only of said cat/ kitten and to replacement only. No refunds. Seller's liability for genetic life-threatening illness or defects shall be limited to one year from date of purchase: And to Replacement only. Cats/ kittens purchased with breeding rights are not guaranteed to produce kittens. In case of proven breeder, copy of litter registrations or offspring may be provided upon request. Said cat/ kitten or its offspring shall not be placed in a pet shop or internet site to be sold. Cat/ Kitten must never be allowed to go outside, and shall be supplied with proper food,

water, and care. Failure to do so shall result in forfeiture of ownership and transfer of ownership of said cat/ kitten back to the seller. If said cat/ kitten is purchased with spay or neuter contract requirement or is not currently spay/neuter, the cat must be spayed/ neutered by the age of 8 months to prevent forfeiture of registration. Written proof of spay or neuter from a licensed veterinarian shall be provided to the seller in order to receive registration certificate. Breeder retains first right of refusal upon purchaser's need to place a whole (unaltered) male or female into another home. Cat/ kittens sold as show prospects are not guaranteed to place in show.
